

Construction Related Hazardous Waste

Scope

Some construction related wastes are hazardous and require special handling. Examples of such wastes include:

- Asbestos Containing Materials •
- Contaminated Soil •
- Contaminated Piping •
- Hydraulic Oil •
- Lead-Containing Materials •
- Mercury Switches •
- Mercury Containing Lamps •

- Motor Oil
- Paint Related Materials
- PCB Containing Caulking
- PCB Containing Transformers
 PCB and Non-PCB Lamp Ballasts
 Radioactive Tritium Exit Signs
 - Radioactive Tritium Exit Signs •

Incorrect documentation, transportation, tracking, and disposal of hazardous wastes can result in costly violations.

Controls

Environmental Health & Safety (EHS) has a list of University of California, Office of the President (UCOP) approved hazardous waste disposal facilities. EHS will provide a qualified person to inspect the shipment for compliance and sign the hazardous waste manifest.

Process

1. When a construction project will generate hazardous wastes, the project manager must have the bidding contractor contact EHS and provide the following information:

Transporter Qualifications

Hazardous Waste Hauler's license and permit.

Insurance Requirements

- Comprehensive or Commercial Form General Liability Insurance.
- Business Automobile Liability Insurance for owned, scheduled, non-owned, or hired vehicles.

Hazardous Waste

- A list of the type of hazardous waste and amount that will be disposed. ٠
- 2. EHS will provide the contractor a list of approved treatment, storage, and disposal facilities (TSDF) that must be used. The approved TSDF will vary depending on the type of waste.
- 3. When the hazardous waste is ready for shipment, the project manager or the transporter must contact EHS to sign the hazardous waste manifest. Please provide 48 hours advance notice for a hazardous waste manifest signature.

Storage of Waste

• Waste must be appropriately labeled and secured in a locked area not accessible to the public.

Treatment Storage and Disposal Facility (TSDF)

• Hazardous and non-hazardous asbestos waste must be manifested to:
